SHIFTING ORDER

WHEREAS, in terms of Section 15 (3) (a) of the NCTE Act 1993, WRC granted recognition to **B.C.G. SHIKSHA MAHAVIDYALAYA, 5, KOTHI ROAD, DEWAS – 455001, MADHYA PRADESH, RUN BY B.C. GAUTAM SHIKSHAN SAMITI, 5, KOTHI ROAD, TEHSIL-DEWAS, DISTT. – DEWAS, MADHYA PRADESH** for **M.Ed.** course vide order dt. **04.01.2008** for an annual intake of **25 students**.

AND WHEREAS, the WRC vide order dt. **06.01.2011** enhanced the intake from **25 to 35 Student** for **M.Ed.** course from the session 2010-2011.

AND WHEREAS, the WRC issued Revised Recognition Order to B.C.G. SHIKSHA MAHAVIDYALAYA, 5, KOTHI ROAD, DEWAS – 455001, MADHYA PRADESH vide order date **16.05.2015** for conducting M.ED. course of two year duration with an annual intake of 50 students (one basic unit) from the academic session 2015-2016.

AND WHEREAS, the institution applied under clause 8 (11) of NCTE Regulations, 2009, for change of premises of M.Ed. course from B.C.G. SHIKSHA MAHAVIDYALAYA, 5, KOTHI ROAD, DEWAS – 455001, MADHYA PRADESH to **B.C.G. SHIKSHA MAHAVIDYALAYA, VILLAGE-NAGUKHEDI (NEAR UJJAIN ROAD), POST OFFICE-DEWAS, PATWARI HALKA NO. 20, SR NO. 108, SURVEY NO. 42/2/2, NAGUKHEDI ROAD, TEHSIL/CITY-DEWAS, DIST.-DEWAS, MADHYA PRADESH.**

AND WHEREAS, the visiting team constituted by the WRC inspected the new premises on **08.04.2016**.

AND WHEREAS, the visiting team report alongwith other documents, videography was placed before the WRC in its **248th Meeting of WRC held on April 11-12, 2016**. The Committee decided that:-

“...The three cases, D.El.Ed. course (APW00601/222029) and (APW02121/222029), B.Ed.(223138) and M.Ed.(225035) were considered together.

The VT report was perused and the CD was viewed. The VT has recommended the case. On perusal of the CD, it has been found that the institution has the required facilities. **Hence, Shifting be permitted.**”

NOW, THEREFORE, in exercise of the powers vested under section 15 (3)(a) of NCTE Act, 1993, permission under clause 8(9) of NCTE Regulation, 2014, is hereby granted for change of premises from B.C.G.
